• Cholla Trail – <u>Jody</u> - drainage channel has made progress. Some neighbors are granting an easement for drainage. Still looking at 6 mo. for permits, plans, design, and construction.

- Bloom Dispensary relocation 4532 E Thomas Rd BOA (5/6) <u>Tristahn, Neal, Jody</u> Neal: Bloom dispensary-- May 6 will be heard by BOA. AONA will present in opposition at the hearing. ACMNA has concerns about the placement on 44th and Thomas. Betty Drake (hearing officer) commented that it is a higher than normal crime area already.
- 4505 N Rubicon (Wright House lot Split) <u>Tristahn</u> preserving the home, want ½ the parcel for a house, all conforming but need a variance for a "flag lot" in the back w/ the driveway entrance on Rubicon. ACMNA did not oppose
- 4061 E Arcadia Lane (Front setback 12', should be side) <u>Andrew and Marvin</u> Variance approved. Moving forward w/ getting building permit.
- 5347 E Wonderview (Front yard setback on the mountain) <u>Heather and Amanda</u> This hillside property wanted a 25' setback (40' minimum) the northwest corner of the <u>existing</u> home is currently 25' from property line. ACMNA did not oppose, the variance was approved.
- 4512 E Lafayette (R-18 wanting 30% in a single story) <u>Tristahn</u> R18s are unusual in Arcadia. ACMNA did not oppose, the variance was approved.
- 5023 E Red Rock Drive setback front yard to 10' <u>Heather Giannangelo</u> will review and submit the letter.
- <u>CC&R resource page</u>, research w/recorder's office, language to consider when updating or creating them. <u>Ian Quinn</u>
 - There's been gap of what people assume zoning protects
 - Arcadia does not have an HOA
 - o Arcadia has pockets of platted communities w/ CCR's and deed restrictions
 - What can we do to help homeowners know their rights etc.
 - Sometimes it's a small group of homes
 - ACMNA is exploring the idea of creating a resource of all of Arcadia's CCR's on ACMNA website (sometimes really hard to find)
 - Have a repository of all the CCR links?
 - Preservation standpoint: empowers homeowners as well as builders
 - Provide some "stock" language in their own CCR's
 - NOT provide legal advice, just provide language and/or suggestions of where to find language
 - Question: Does the Board feel it's a value-add?
 - Preservation standpoint: empowers homeowners as well as builders
 - Question: What Board members are interested in working w/ lan during summer?... and then present to the Board in the fall?

Budget update, Donations update

- Covid has actually helped our donations.
- March donation activity continued to flow in with an additional \$240 in contributions.

AUTORAMA - In addition to the 2 sponsorship donations of \$500ea from Courtesy Chevrolet & Chapman Ford, we received almost \$900 in event registration payments

- ~45 cars so far
- Tristahn received a couple more today.
- Tristahn has a check he'll turn in to Michael.
- Total budgeted income for the event was \$1,500, so already ahead of the goal!
 Expenses not paid yet.

Block watch- approved for \$12K grant for next year.

- Expenses of note were the credit card payment for the January Newsletter \$1,287.87
- (Block Watch expense) and AutoRama advertising \$110.

We approved \$2K for legal fees for the Superior Court Case regarding digital board... Neal has approached us for the second \$1K need. It has already been approved, so we are just distributing the check now.

End of year. Taxes: still waiting for CPA. Still need them in by April.

- Annual report filing, what do we need?
 - o Craig: all on line. List names of the officers and contact info.
 - o Pay \$10 (or \$45?) by credit card. Easy.

Discussion:

- Question: Andy- has the Board ever done anything w/ unpermitted construction?
- Answer: <u>Tristan</u>- Board is happy to tell how to report that, but the Board is not in the job of "Permit Police".
- Andy- will write an article about "what to do if you see unpermitted construction, or have an issue w/ a builder who doesn't seem to be following the rules".
