- **Camelback Church of Christ 4x8' Digital Display** Denied They got the digital sign, but they can only change the message once/ day. They cannot have a rotating message.
- 5035 E Lafayette Pool House with a Kitchen 1/20/22 Hearing
 - This is a request to replace an existing pool house with a new 1,264 SF single-story pool house with a full kitchen
 - The lot is .48 acres
 - It is a corner house, and the existing pool house is on the southwest corner of the lot about 3' from the property line. We do not know the size of the current pool house, but there does not appear to be an issue with lot coverage.
 - There was discussion about what the homeowner wants and why. Many questions were unanswered from the information provided.
 - General consensus was that although the homeowner is calling it a "pool house", essentially, it is a fully-equipped guest house (the "rec" area can easily be converted to a bedroom).

- The Board decided to "Table" the discussion until January's meeting when more information can be provided.
- Two guests at the Board meeting voiced their opinion:
 - Guest (Guy Vale) input: the single biggest degradation to Arcadia is the STR's. He has 3 homes with guests houses that are rented out all the time on his street alone. Guest homes/structures increase the density, "killing" our open space. Homeowners are battling this nonsense day-in-and-day-out. Arcadia is becoming commercialized. We need to stop this from happening.
 - Guest (Nini) input: the three homes near them have guest houses that are complete nuisances year-round- noise, traffic, trash...

- Cholla Trail Jody
 - Host/ City of Phx Parks signed the letter of intent. City Council still needs to approve it, it's in the works.
 - Fences have been put up ... moving boulders, beginning the drainage
 - Have permits
 - When completed, Parks will be responsible for locking/ unlocking the gate
 - Problem still exists: the parking has still not been addressed.
