Preservation | Tristahn Schaub

- Church Sign on Camelback scheduled for Jan 18th hearing (to revoke the use permit)
- Jack Keeney will follow-up about the training for Board of Adjustment
- ACMNA is currently in lawsuit w/ company filing to change the billboard at 44th St. and Indian School rd (near Chic Fil A property)
 - We had Mid-town law handling the rebuttals etc.
 - Oral arguments take place in Jan.
 - ACMNA and AONA have \$7,741 in outstanding bills that need to be paid by 5:00pm tomorrow, Dec. 8th
 - ACMNA paid \$2K in the beginning, AONA has been paying some of the bills, but two weeks ago, Neil Haddad (AONA President) had an accident and the bills didn't get paid
 - Mid-town law has quoted \$2K for oral arguments



- Tristahn proposed ACMNA splits the outstanding bill w/ AONA, \$3,870ea, but in the meantime, ACMNA pay the outstanding bill by 5:00pm Dec 8.
- Motion- <u>Tristahn Schaub</u> 2nd: <u>Dennis Frank</u> Motion: ACMNA will pay the current outstanding balance of \$7,741 to prevent w/drawl of representation. All in favor. No one opposed. Motion passed.
- Discussion was had regarding AONA paying ½ of the fees, a call was made to Neal. AONA agreed to reimburse ACMNA for ½ the cost.
- 5040 Arcadia Drive. Ongoing variance. The owner was not at the hearing today. The variance was rescheduled for Jan 16.
