Community Action Officer, Jared Sherman

- Recent event publicized: Armed 15-17yr olds in backyard w/ guns. 15-17yr olds. Three of the five have been arrested, the other two will be soon. PD's of Glendale, Gilbert, Chandler, coordinated with Phoenix to capture these kids.
- Encourage the community to call about ANY suspicious activities.
- Alarm systems and cameras were responsible for being able to find/arrest these people.
- **Non-emergency police number is 602-262-6151** (911 will also route you to the non-emergency dispatcher) Text 9-1-1 is city-wide up since April. **If you are in your home, can text to 911. Put your phone on vibrate.

- Jim Carland- suggested remove the "non-compliance" line b/c we cannot enforce it etc.
- Tristahn- Once the other builders agree to the List of Rules, we will put the rules on ACMNA website.
- Richard Rae- suggest a line: "that the builder is responsible for the work done by subs."

- ACMNA's position: a rule is a rule. Jim Carland- suggests ACMNA send a registered letter to Alan to ensure that Alan is aware of the ordinance. The letter should be on our letterhead, highlight where the existing group homes are, and what the ordinance is.
