### 56<sup>th</sup> Street Improvement Update

October 202:

Funding for the design phase of the 56<sup>th</sup> Street (Thomas to Camelback) has been appropriated and Phoenix is sourcing a design consultant.

Construction is expected to begin Fiscal Year 2024 (July 2023 – June 2024). Federal funding of \$1.5 M was obtained from the Maricopa Association of Governments. However, this is only enough funding for a portion of the project. A \$5 million federal earmark request has been included in the House Surface Transportation bill that's being negotiated in Congress right now. This would cover the balance of construction funding.

# ARCADIA UNDERGROUND

The ACMNA board has been investigating the possibility of having overhead utilities (electric, cable, phone, internet) buried underground. You may be aware that the City of Paradise Valley made the decision several years ago to move utilities underground; this would be a similar effort for the Arcadia – Camelback Mountain area.

The advantages of moving utilities underground are:

- Aesthetics the environment looks more natural, with unobstructed mountain and city views.
- Reliability less vulnerable to storm damage. Recent monsoon storms caused outages in the Arcadia area.

- Safety no downed power lines, no lines overhead to be accidentally contacted by trucks, ladders, palm fronds, etc.. Roof rats do not have a cable to shimmy along to reach your home.
- *Upgrade* fiber optic internet to every home

Arizona Revised Statues, Article 6.1, § 40-341 to 40-356 covers how property owners may form *Underground Conversion Areas* for the purpose of having overhead utilities converted into an underground system in their neighborhood.

The process to create an underground conversion area involves two petitions. If 60% of property owners sign a petition to express interest in underground conversion, the utility companies have 120 days to develop a cost commitment for the conversion and

inform each property owner of their proportionate share of the costs. A second petition is then circulated, and if 60% of the property owners sign their approval, then SRP will petition the City of Phoenix Board of Supervisors to create the underground conversion area. Property owners pay their share of costs 60 days after their property is converted, or they can choose to pay (with interest) over 15 years.

# Popular Trails Closed During Heat Advisories

Hiking the two Camelback trails and one Piestewa trail will off-limits between the hours of 11 AM and 5 PM during the hot summer months when the Weather Service issues an Excessive Heat Watch (105° and above).

In recent years, Phoenix Fire has seen an increase in the number of rescues on our three most extreme city hikes - Piestewa Peak and Camelback's Cholla and Echo Canyon Trails. Rescues have become more dangerous as the temperatures rise, resulting in hospitalizations not only for hikers but rescue workers as well.

Closures will be based on forecasts made 2 days in advance and will be based on the heat index, not the actual temperature. For example, during monsoon season, when the relative humidity hits 40%, the heat index will hit 105 when the air temperature is 98°.


Hikers may still use the trails between 5 AM – 11 AM, and 5 PM – close on high heat days.

### **Camelback Water Tank Protest**

The City of Phoenix recently notified neighbors in the area that the two 100,000 gallon water tanks on the eastern side of Camelback Mountain are set to be replaced with two 200,000 gallon water tanks to support dozens of new homes being built at the Phoenician. The tanks would be no higher, but wider.

Current Phoenix design standards call for new water tanks to be placed below ground. However, Phoenix is planning on keeping the new tanks above ground.

Neighbors have organized to protest and demand the replacement tanks be buried, or partially buried so they are no more than eight feet high (which could then be hidden by landscaping).

# What I love about Arcadia Trees

Many of you may not be aware that Arcadia was at one time a desert. Old photos of Camelback Mountain show scrub brush and saguaro cactus as far as the eye can see.

Today, we cannot imagine our neighborhood without the beautiful and bountiful trees. They line our streets, shade our pools and just add to the ambiance that is Arcadia.

The name "Arcadia" comes from the Greek culture, referring to the garden of the Gods.

The original intent and purpose for developing Arcadia was to build citrus groves back in the early 20th century. The Arcadia Water Company was found-

ed in 1919 for the very purpose of taking water from the Arizona Canal to irrigate the newly platted farms that would

attract wealthy investors. Lot sizes ranged from 5 to 10 acres each. Citrus trees were planted, with some of their "offspring" still residing in many of the yards today.

In the 1950's, after WWII, planting houses became more profitable and popular. Many other varieties of trees were brought in to make the landscapes more picturesque and attractive. Irrigation made it possible to grow just about any type of tree so new homeowners brought their favorite trees from wherever they considered "back home". Everything from Palm to Pines flourished in the rich soil and abundant water.

There are several great neighborhoods, new and old, in the Phoenix metro area, but, in my opinion, none has the richness and charm as our tree covered yards. We truly live in the "garden of the gods".
